

## SPALC AND TALC CONTRACT NEGOTIATIONS FY20 (2019-2020 SCHOOL YEAR) JOINT COMMUNICATION

## March 20, 2020 - 4:00 p.m. - Joint Communication #4

SPALC, TALC, and District leadership teams met again this afternoon to discuss implementation of contingency plans for the District's response to the Coronavirus (COVID-19) pandemic. Plan development is ongoing and rapidly changing. Your patience is appreciated.

SPALC, TALC, and the District are working to provide employees with accurate information in a timely fashion. Mobilization of a large-scale operation necessary for continuity of student instruction is extremely complex and requires the involvement of a number of key stakeholders. A large part of this effort centers around communication, which is why it is appropriate to address information leaks and the spread of misinformation.

A person who is the source of a leak or misinformation may be well intentioned in their efforts to "get the word out." However, the untimely release of tentative plans and the premature release of privileged information creates a significant hardship for leadership teams tasked with responding to already the rapidly developing situation. Time spent addressing leaks and misinformation could be better spent addressing individual and strategic concerns.

People with access to confidential or privileged information are encouraged to keep this information confidential. Noise and static are inevitable as some people respond to unwelcomed changes. All District employees are encouraged to remain calm and conduct themselves in a professional manner in all interactions with students, parents, colleagues, and the public.

The health, safety, and welfare of students and employees depends on the success of our communication and your ability to rapidly deploy innovative educational measures in an uncertain and ever-changing environment. We are confident in your ability to do so, since this is and always has been an essential part of being an educator.

SPALC, TALC, and the District have agreed to the publication and distribution of joint communications on regular intervals. All joint communications will be numbered and will include a time and date. Information shared via press releases and media conferences may include details of tentative plans. Plans that impact terms of employment must and will be finalized with input from and involvement of SPALC, TALC, and District leadership.
